### Suggestions For Meeting with Farm Loan Officer



Identify your operation or what type of operation you want to have



Know your costs, bring records to the appointment (Lease agreements, ownership records, tax returns, sales contracts, construction quotes) ~~

Build a farm business plan ( marketing , income projections, costs



Keep records organized. What household expenses affect the farm? (medical, food, taxes, education, credit card payments)



Determine Financing ( how much do you need?)





# Farm Loans

- Developed to serve financial operating needs of new, niche, and small family farm operations
- Two Types :Operating
  & Farm Ownership
- Offer more flexible access to credit for smaller operations







# Operating Loans

### Can be used to purchase:

- Equipment
- Livestock
- Production expenses
- Refinance operating expenses

Operating loans can be repaid in 1-7 years.

Limit is \$400,000.





### Farm Ownership Loan

Ownership loans can be used to pay for:

- Land purchases
- Capital improvements
- Soil and water conservation
- Loan closing and related expenses

Farm Ownership loans can be repaid in up to 40 years. Limit \$600,000



# Farm Loan Programs

# FSA Eligibility

FSA is supervised credit: this is different from traditional credit. FSA is the lender of first opportunity for those who may not otherwise qualify for ag credit. FSA makes and services direct loans through supervised credit with funds from the U.S. Treasury. FSA also offers loan guarantees for loans made by conventional lenders.

#### Direct and Guaranteed applicants must:

- Be unable to obtain sufficient credit elsewhere
- Be a citizen or a legal resident alien
- Possess legal capacity to incur the loan obligation
- Have acceptable credit history
- · Be the owner-operator or tenant-operator of a family farm





# **Eligibility Continued**

Direct and Guaranteed applicants must:

- Not be delinquent on federal debt
- Have managerial ability for the type of loan requested
- Not have caused the agency a loss by receiving debt forgiveness (some exceptions)
- Not have been convicted of planting, cultivating, growing, producing, harvesting, or storing a controlled substance within the last five years





# Farm Ownership Program

- For ownership loans still need to have three years of farm experience out of last 10 prior to application date.
- Substitutions for one year are allowed in certain instances
  - Post-secondary education no less than16 semester hours of ag-related course work
  - Significant business experience of at least one year that included day-to-day management
  - Military experience officer or E5 or above.
  - Repayment of an FSA youth loan





# What is a complete application?

#### Actual Application Form:

- FSA-2001
- Entity information, if applicable.
- Legal description of farm property owned or to be acquired and if leases, contract options, and other agreements regarding the property.
- Tax Returns
- Documentation of Environmental Compliance (AD-1026)
- Current Financial Statement & Operating Plan
- Legal Description of farm property owned.
- Credit Report Fee.

#### Additional Information, If Applicable:

- Verification of nonfarm income, if applicable.
- Construction plans, quotes, and permits
- Option to purchase real estate (contract)
- Insurance





## Loan Processing – What To Expect

### **Current Balance Sheet (Snapshot)**

- Assets
- Liabilities/Debts

### Farm Assessment

- Goals for your operation
- Farm organization and personnel
- Historical performance (3 years)
- Adequacy of land, facilities, and assets for planned operation
- · Establish a good recordkeeping system









### Loan Processing-What To Expect

#### Marketing plan

- How will you sell your products?
- · How much do you expect to get?
- Contracts and verifications



# Projected Income and Expenses (12-month period)

- Based on historical production and/or documented research
- · Do you have a financially viable operation?

# Loan Processing-What To Expect

### **FSA Response:**

- FSA will review submitted documents
- Most officials will call and discuss application with customer.
- If incomplete, a letter will be sent by mail within 7 calendar days of receipt via written communication with additional information required.
- Applicant is given 15 days to provide information.







# Loan Processing-What To Expect

### **FSA Response:**

- If applicant does not respond or supply necessary information within 15 calendar days specified in first letter:
  - 2<sup>nd</sup> Letter Sent With Due Date of 15 Calendar Days
  - Application will be withdrawn after that time period lapses.
- Application is withdrawn if material is not provided within 30 calendar days.

# How to become Eligible for Cost Shared Assistance...

- Contact your Local Farm Service Agency (FSA) request a Farm and Tract Number
- 3 Eligibility documents you must fill out:
  - AGI (Adjusted Gross Income Form)
  - AD-1026 Form (Highly Erodible Land)
  - 901/902 Farm Plan

Now that all the documents above are in the system- you can proceed with applying for Cost Shared Assistance through NRCS


